
Sir,

With reference to the subject cited above, I am directed to inform you that consequent upon the decision regarding Amendment to Rule 143(i) & (ii) of AS(P) Rules, 1969 communicated vide Notification No. PPG(G) 10/2013/38, dated 20/08/2015, the Accountant General (A&E), Assam has raised certain points for further clarification vide their letter under reference. To meet the above points the Govt. in the Pension & Public Grievances Department have clarified the matter vide letter No. PPG(G) 10/2013/41, dated 11/01/2016.

It is further stated that the above Notification No. PPG(G) 10/2013/38, dated 20/08/2015 was issued in pursuance of Cabinet decision dated 27/07/2015 with the concurrence of Finance (EC-III) Department conveyed vide their U/O No. FEC (III) 936/14, dated 12/09/2014 and the date of effect of the Notification No. PPG(G) 10/2013/38, dated 20/08/2015 (a copy of which is enclosed for ready reference) will be from the date of issue i.e. 20/08/2015 as provided in Rule 525 of the Assam Financial Rules.

The Cabinet by this decision allowed a new benefit to the Family Pensioners vide Govt. Notification No. PPG(G) 10/2013/38, dated 20/08/2015 and benefits to be extended to cases admissible under the provisions of the said Notification will be effective from the date of Notification and not retrospectively.


