Sub : - Delegation of powers to Pension and Public Grievances Department.

Consequent upon the creation of the "Pension and Public Grievances Deptt." vide A.R. Deptt. Notification No. AR.52/83/7 dated 2.9.86 for administration of all legislation rules etc. relating to Pension. Provident Fund and Group Insurance Scheme, the Governor of Assam is pleased to empower with immediate effect, the said Pension & Public Grievances Deptt. To exercise the financial power so far exercised by Finance (AF) Deptt. As Administrative Deptt in respect of the :-

- (1) Assam Service (Pension) Rules, 1969.
  - (2) Assam Service (Commutation of Pension) Rules 1965.
  - (3) Assam Service (Extra- ordinary) Pension Rules 1963.
  - (4) Assam Service (Compassionate Fund) Rules 1962.
  - (5) G.P.F. (AS) Rules.
  - (6) State Govt. Employees Group insurance Scheme.
  - (7) Special family pension to the families to officers killed while on duty.
2. Special Family Pension and Extra-ordinary Pension shall be sanctioned with the concurrence of Finance Deptt.
3. Relaxation or amendment of any rule where necessary shall be done in consultation with Finance Deptt.
4. The Secretary, Pension & Public Grievances Deptt. Is also declared as Controlling Authority in respect of Budget grant under the Head "266 Pension and other Retirement Benefits" for the current financial year and the Head of Account "2071 Pension and other Retirement Benefits" with effect from the financial year 1987-88 together with corresponding receipt head of account.
