Consequent upon the decision taken by the Govt. of India in respect of enhancement of D.C.R.G. in case of the Central Govt. employees, the Governor of Assam of the Central Govt. employees, the Governor of Assam is pleased to decide that the existing provision containing in para 9 of O.M. NO.PPG(P) 164/98/66 dtd. 19.11.98 under the Assam Services (Pension) Rules, 1969, may be revised as follows :-

The existing limit of `2.00 Lakhs for maximum benefit of D.C.R.G. in case of State Govt. employees as provided under para 9 of Pension & Public Grievances Deptt.' O.M. No.PPG(P) 164/98/66 dtd. 19/11/98 shall be enhanced upto maximum limit of `3.50 Lakhs.

This amended provision will come into force with effect from 26-3-2001.

Necessary amendment to the Assam Services (Pension) Rules, 1969, in terms of the decision contained in the O.M. will be issued in due course.
