**OFFICE MEMORANDUM**

Government vide para 12 of Govt. O.M. No.PPG(P)129/2004(A)/189 dated 05-06-2006 has stipulated that each pre 01-01-1989 pensioner/family pensioner who was in receipt of pension/family pension as on 01-01-1996 is required to apply for revision of his/her pension/family pension in the prescribed form(in duplicate). In the prescribed form, it is stipulated that Accountant General, Assam/Director of Pension, Assam are required to verify the points 2,3,5 and 6 of the prescribed form with Signature and rubber stamp.

Govt. after careful consideration, in partial modification of para 12 of the aforesaid O.M has decided to dispense with the verification of Accountant General, Assam/Director of Pension, Assam in the prescribed form. Henceforth the pensioners/Family pensioners will submit their applications in the prescribed form to their respective Head of Offices within 60(sixty) days from the date of issue of this O.M. The verification should now be done at the level of Head of offices invariably. The Head of office while forwarding of pre 01-01-1989 revision cases by fixing the pay on notional basis as per the Assam Services ( R.O.P) Rules of the relevant time to Accountant general, Assam and the Director of Pension, Assam as he case may be must invariably mention the details of length of service rendered in case of each Non-Gazetted pensioner and Non-Gazetted portion of service rendered in the case of each Gazetted pensioner and the scale of pay drawn by them from time to time.
