**ORDERS BY THE GOVERNOR OF ASSAM  
OFFICE MEMORANDUM**

Dated Dispur, the 13<sup>th</sup> December, 2011.

Of late it has come to the notice of the Govt. that pensioners are facing financial hardship due to non finalization of pension in time.

It is also observed that some times pension papers are submitted by the competent authority to the A.G.(A&E), Assam and Director of Pension, Assam as the case may be without issuing the provisional pension for the initial 1(one) year in spite of there is clear instruction issued vide this Department's O.M. No. PPG(P)227/04/08 dated 1/12/2004.

In the meantime the A.G. (A&E), Assam vide No.Pen-1/Assam ROP-2010/2009-10/2130 dated 22/3/2010 has requested Govt. to issue Provisional Pension Compulsorily to the retired employees before submitting pension papers to the A.G.(A&E), Assam and Director of Pension, Assam as the case may be for final disposal.

After careful consideration of all aspects the Govt. decided that henceforth all Administrative Department/Heads of Department and the head of office of the Districts shall issue Provisional Pension/Provisional Family Pension and DCRG to all retired employees as admissible as per rules for initial 1(one) year or the strength of the earlier Govt.O.M.No.PPG(P)227/04/08 dated 1/12/2004 under provision of Rule 22(I) of Assam Sevice Pension Rules 1969 before submitting the pension papers to the Accountant General (A&E) Assam and the Director of Pension, Assam as the case may be.
