GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR EDUCATION (ELEMENTARY) DEPARTMENT

NOTIFICATION

The 10th November, 2005

No. AEE. 153/2005/Pt/74 – In exercise of powers conferred under Rule 12 of Assam Elementary Education (Provincialisation) Rules, 1977 the following Amendment is made in the Assam Elementary Education (Provincialisation) Rules, 1977.

- 1. **Defination**: This Rules may be called the Assam Elementary Education (Provincialisation) (Amendment) Rules, 2005.
- 2(a). In principal Rules 2 the following shall be substituted as under :
 - viii. H.S. means Higher Secondary.
 - ix. HSLC means High School Leaving Certificate.
 - x. 'Lower Primary School' means the School imparting Education up to Class IV.
 - xi. 'Mil' means Modern Indian Language.
 - xii. 'Upper Primary School' means the institution imparting Education upto Class VII including ME School or MV School or ME Madrassa or Senior Basic School individually or a combination of any two or three of or all he four categories of these institutions.
- 2 (b). In principal Rule 2 the clause 'viii' shall be re-numbered as (xiii).

- 3 (a). In the principal Rule 3 (i) as amended for clause 3 (i) (a) the following shall be substituted namely:
 - " (i) In the month of January every year the Director of Elementary Education, Assam (hereinafter called DEE), shall invited applications in prescribed form, to be submitted to as directed, through advertisement in news papers from desirous candidates prescribing minimum qualifications, number of vacancies, category-wise reservation for Scheduled Caste/Scheduled Tribes/Others Backward Classes/Persons with Disabilities/Sons and Unmarried Daughters of Retired Teachers and Ex-servicemen as prescribed by the Government from time to time."
- 3 (b). In the principal Rule in Rule 3 for clause (iii) the following shall be substituted namely:
 - "(iii) Qualifications:
 - (a) Assistant Teacher: Minimum Qualification Higher Secondary or any other Examination of Equivalent standard having 45 % marks in any one of the qualifying Examination (Higher Secondary or HSLC) for general categories and minimum 40 % marks for reserved categories shall be the minimum Qualifications for the posts of Assistant Teachers in Lower Primary and Upper Primary Schools.
 - (b) Hindi Teacher: HSLC Examination passed along with Hindi Visharad of Assam Rastrabhasa Prachar Samiti or Higher Secondary (HS) Examination passed with Hindi as one of the subjects or equivalent thereof.
 - (c) Arabic Teacher: Intermediate Examination passed under Madrassa Education Board, Assam or Higher Secondary Examination passed with Arabic as one of the subjects or equivalent thereof.
 - (d) Language Teacher: Higher Secondary Examination passed with certificates of Language Examination from competent authority and Board Examination at the HS level.
 - (e) Science Graduate Teacher: B.Sc. from any recognized University.

Preference shall be given to trained candidate."

4. In the principal Rules in rule (v) for the existing provisions the following shall be substituted namely Rule - (v):

"v) Selection Committee:

a) There shall be a District Level selection Committee (henceforth termed DLSC) in each educational District constituted as follows :

A. An Eminent Educationist/Social Worker : Chairman/Chairperson

B. 7 Educationists and Social Workers to be nominated by State Government, at least two each should be from Women and parents and at least one should be from the weaker section to be nominated by Govt.

C. The Deputy Inspectors of Schools of the Districts
(All) under the Districts Elementary Education
Officer concerned.

- D. The District Elementary Education Officer of the : Member Secretary District concerned.
- b) The term of the nominated members shall be one year from the date of notification of the constitution of the Board. The term may, however, be extended by the Government for a period as deemed necessary by the Government.
- c) The Chairman/Chairperson of the DLSC may constitute as many Interview Committees, as he/she may think necessary from among the members of the DLSC to expeditiously deal with the large number interviews to be conducted and each Interview Committee may conduct interviews at more than one place as per convenience.
- d) Each Interview Committee shall have a minimum of two members out of which Chairman/Chairperson DLSC/ one nominated member of DLSC shall be the Chairman/Chairperson of the Interview Committee."
- 5. In the principal Rules (vi) for existing provisions the following shall be substituted namely: "vi) *Selection Procedure and Appointment :*
- a) The Selection Committee, on receipt of the applications, shall scrutinize them along with mark sheets and other necessary testimonials of the candidates for their interviews by the Interview Committees for each Assam Legislative Assembly Constituency. The DLSC, on completion of interviews by different Interview Committees shall add the marks secured by different candidates in the interview (viva-voce), marks secured due to general qualifications of the candidates and the marks secured for experience and training, with the marking pattern provided in the Schedule-I of this rule. The DLSC shall then prepare a constituency-wise list/lists of the suitable candidates considering their academic achievements as well as their aptitudes in the job and knowledge in the descending order as per the Schedule-I appended hereto.
- b) The DLSC shall finalize the select list in order of preference of different categories of candidates as follows:
 - (A) One select list containing the top-scoring candidates, irrespective of their castes/tribes and categories. This list shall contain names of the candidates with their Roll Numbers, Castes/Tribes/Categories and Total Marks obtained, in order of merit. This select list shall contain names of candidates double the number of the unreserved category of vacancies notified.
 - (B) Separate select lists for each constituency in order of preference belonging to Scheduled Castes/Scheduled Tribes/Other Backward Classes and More Other Backward Classes, Persons with Disabilities, Sons and Unmarried Daughters of Retired Teachers, Ex-servicemen and others as per rules twice the number of vacancies notified excluding the vacancies for appointment on compassionate ground, irrespective of candidates included in the list of top-scoring candidates, prepared as per.
 - (C) DEE shall issue the appointment letter to the candidates from the select lists of the DLSC in a salary provided by the Government from time to time till the successful completion of the prescribed training.
 - (D) The teachers shall enjoy the prescribed pay scale with effect from the date of declaration of the training examination results.

- (E) Any appointment, except that made on compassionate ground, to any person outside the select list/lists shall be-initio invalid.
- (F) The list mentioned in clause (vi) (b) above shall remain valid for 12 calendar months from the date of recommendation."
- 6. In the principal Rules (vii) for the existing provision the following shall be substituted namely:

"(vii) Reservation:

There shall be reservation of posts for Scheduled Castes, Scheduled Tribes, Other Backward Classes and More Other Backward Classes, Persons with Disabilities, Sons and Unmarried Daughters of Retired Teachers, Ex-servicemen and others as per rules. The number of posts to be filled up by compassionate appointment during the year shall be notified in the advertisement referred to in Rule 3 (i)."

7. For the **Schedule-I** in the principal Rules of the existing provisions the following shall be substituted:

"Schedule-I

[See Part-I. Rule 3(vi)(a)]

Selection of teachers for Lower Primary and Upper Primary Schools shall be made on the basis of marks obtained out of total marks of 220 apportioned for general qualifications, experience, training and interview as under:

- 1. (a) Credit for the HSLC Examination or its equivalent: 100 marks, which shall be directly proportional to the percentage of marks secured in the HSLC Examination; for example, if a candidate secures 54% aggregate marks in the HSLC Examination, he/she shall be given 54 marks for the HSLC Examination.
- (b) Credit for the marks secured in the Higher Secondary Examination or its equivalent: 100 marks, which shall be directly proportional to the percentage of marks, secured in the HS Examination. For example, if a candidate secures 42% in the H.S. examination, he/she shall be given 42 marks for the H.S. Examination.
- 2. Credit for experience as teachers in provincialised pre-primary schools or preprimary schools under grants-in-aid: 10 marks, which shall be credited at the rate of 1 marks for each completed year and one mark for a period exceeding six months, subject to a maximum of 10 marks in total.

Or

Credit for passing Junior Basic Training/Senior Basic Training/Normal Training Examination Diploma in Elementary Education (Two-year Course): 10 marks.

3. Interview (Viva-Voce): 10 marks, which shall be given on the basis of performance of the candidate in the interview. The marks credited shall be the average of the marks given by each individual member of the Interview Committee."
