OFFICE MEMORANDUM

Consequent upon issue of circular No.BW.3/2003/pt.II/1 dated 25.1.05 on applicability of New Contributory Pension Scheme in respect of Government servants joining the State Government services on or after 01.02.2005, a question has arisen about Work Charged employees and Muster Roll employees who entered Government services prior to 01.02.2005 but whose regularization where done after 01.02.2005. A substantial portion of their Work Charged and Muster Roll service have already been decided to be counted towards qualifying service for pension/Gratuity.

It is clarified that such Work Charged and Muster Roll employees shall not be governed by the New Pension Scheme but may be treated as per existing Assam Services (Pension) Rules, 1969.

Similar such cases, if any, may be entertained after obtaining the views of concerned Departments including Finance Department and approval of the Secretary of the concerned Administrative Department.
