CORRIGENDUM

The Govt. of Assam in Finance Department vide circular No. BW 3/2002/Part.II/1 dated 25/01/2005 have decided to formulate introduction of contributory pension scheme for all the employees joining the State Govt. Services on or after 1/2/2005 in the line of Govt. of India, which was one of the conditions at the time of executing tripartite agreement for Asian Development Bank fund under Governance and Public Resource Management Programme. Accordingly the Governor of Assam is pleased to introduce "The New Defined Contribution Pension Scheme" for all new entrants joining the State Govt. Services on regular basis against sanctioned vacant post on or after 1/2/2005 vide Finance (Budget) Department O.M. No. BW.7/2008/Pt/40 Dated 06/10/2009.

In view of above to implement " The New Defined Contribution Pension Scheme, 2009" for all the employees joining the State Government Services on or after 01.02.2005 the existing pension Rules "The Assam Services (Pension) Rules,1969, and G.P.F. Rules, 1937 have already been amended with the approval of 'Cabinet' held on 05/07/2011 and accordingly Notification were issued vide **No-PPG(P) 88/2009/37 dtd 13/7/2011** and **No-PPG(P) 88/2009/38 dtd 13/7/2011 to all concerned.**

The above two Notification **No-PPG(P) 88/2009/37 dtd 13/7/2011** and **No-PPG(P) 88/2009/38 dtd 13/7/2011** should have been **No- PPG(P) 140/2009/37 dtd 14/7/2011** and **No-PPG(P) 140/2009/38 dtd 14/7/2011** which were inscribed wrongly through oversight.

Subsequently a corrigendum was issued in this regard vide No-PPG(P)140/2009/39 dtd 12/9/2011.

Now, to impress upon the importance of the matter it is felt imperative that a self contained *Corrigendum* elaborating the matter in brief need to be issued again and as such all concerned are requested kindly to read the Government Notification as **No-PPG(P) 140/2009/37 dtd 14/7/2011** and **No-PPG(P) 140/2009/38 dtd 14/7/2011** instead of No-PPG(P) 88/2009/37 dtd 13/7/2011 and No-PPG(P) 88/2009/38 dtd 13/7/2011.
