NOTIFICATION

NO.PPG(P) 148/92/83: - In exercise of the powers conferred by the provision to Articles 309 of the Constitution of India the Governor of Assam is pleased to make the following Rules according the Note 2 below rule 143 (i) of the Assam Services (Pension) Rules, 1969, namely:-

Short title & Commencement

- 1) These Rules may be called the Assam Services (Pension) Amendment Rules, 1995.
- 2) They shall come into force with immediate effect.

Amendment

The Note 2 below Rule 143(i) of the Assam Services (Pension) Rules, 1969 shall be substitute by the following:-

“Note-2

(a) Marriage for the purpose of admissibility of pensionary benefits to the spouse of a retired official shall mean marriage before or after retirement.

(b) Child/ Children fo the purpose of pensionary benefits of a retired official shall mean child/ Children born before or after retirement.”
