**OFFICE MEMORANDUM**

Sub : **Release of Arrear pension of the State Govt. Pensioner/Family Pensioner/Extra ordinary pensioners revision for the period between 1/10/2008 to 31/3/2009.**

Consequent upon Govt. decision regarding payment of pension at revised rates w.e.f. 1/10/2008 to 31/3/09 communicated vide O.M. No.PPG(P)88/2010/51 dated 26/4/2011 where upon the A.G. (A&G) Assam has raised question **vide letter No.PEN-1/Assam ROP/2009-10/168 dated 10-5-2011** for certain modification of clause (5) of the Govt. O.M. No.PPG(P)88/2010/26 dated 1/6/2010 and clause 11(1) of the Govt. No.PPG(P)88/2010/27 dated 1/6/2010.

To meet the above points the Govt. of Assam is pleased to modify the clause (5) of the Govt. O.M. No.PPG(P)88/2010/26 dated 1/6/2011 and clause 11(1) of the O.M. No.PPG(P)88/2010/27 dated 1/6/2010 and allow, payment of Arrears of revised pension for the period from 1/10/2008 to 31/3/2009. The rates of the Dearness Relief during this period are as follows :

From 1-10-2008 to 31-12-2008	16% of pay
From 1-1-2009 to 31-3-2009	22% of pay

The interim relief drawn for the drawn for the period between 1.10.2008 to 31.3.2009 will be adjusted (deducted) from the arrears out of revision of pension for the period between 1.10.2008 to 31.3.2009.

This additional arrear of pension will be released in a single instalment.
